

'Intensive' EMT student,

This document will supplement your research about working as an EMT-B in other states once you earn your National Registry of EMT and/or North Carolina credentials. NREMT is the broadest certifying agency for credentials, granting reciprocity in 40 states. If you're NREMT certified you will often have to take additional continuing educational pieces or tests to meet each individual state's requirements. Each state sets rules for whether your certification will be accepted. Unfortunately states change rules w.out notifying the National Registry, so you'll have to verify the current requirements.

Common reciprocity requirements:

- Current and valid NREMT certification or state certification
- Current state training meets the training requirements for the state in which you are applying
- Provide documentation of course completion initial certification at you're level and/or course completion of a refresher course
- Written exam if you are not an NREMT Background check and possible finger printing
- Many states will waive further testing if you are an NREMT / some states require an additional practical exam testing your skills.
- Some states require additional training to understand specific state protocols and procedures.

Alabama reciprocity information: <u>www.adph.org/ems</u> and <u>http://www.adph.org/ems/Default.asp?id=816</u> Alabama requires NREMT certifications. No additional written exam required. You have to be NREMT to come into the state and then also take the AL Protocol education, which is 4-6 hours. The Protocol education has to be done by an Alabama service or one of our Regional EMS Offices.

You are required to submit an application & a copy of your National Registry certificate, wallet card & a Statement of Good Standing (DH Form 1164)

If you currently hold an EMS certification or license from another state or the U.S. Military you may be able to obtain a New York State Certification through the reciprocity process.

Ohio recognizes both NREMT and other state certifications. No additional testing required. Verification Form is to be forwarded (by the candidate) to the state-certifying agency of the state in which initial training was completed, as well as any other state in which you hold, or have ever held, certification. The verification form will be used to determine if additional course work is needed to meet Ohio curriculum requirements.

Currently, they require NREMT for the licensure/certification of some, but not all, levels of EMS personnel. It grants reciprocity on a case-by-case basis for out of state applicants in levels for which it does not recognize national certification. Phone: 717-787-8740

You can become a South Carolina EMT if you hold a NREMT designation. You can also become a South Carolina EMT if you only hold a state certification. Within a year, you must obtain your SC EMT certification.
